The Association will not favor or disadvantage anyone by reason of the amount of their contribution, and you may refuse to contribute to the PAC without reprisal by the Association. 40% of each contribution is used by HRRPAC. Up to 60% of each contribution is sent to National RPAC and is charged against your limits under federal law (2 U.S.C. 441a); National RPAC returns up to 30% of your contribution to Virginia RPAC for use in connection with the election of state and local candidates in Virginia.
